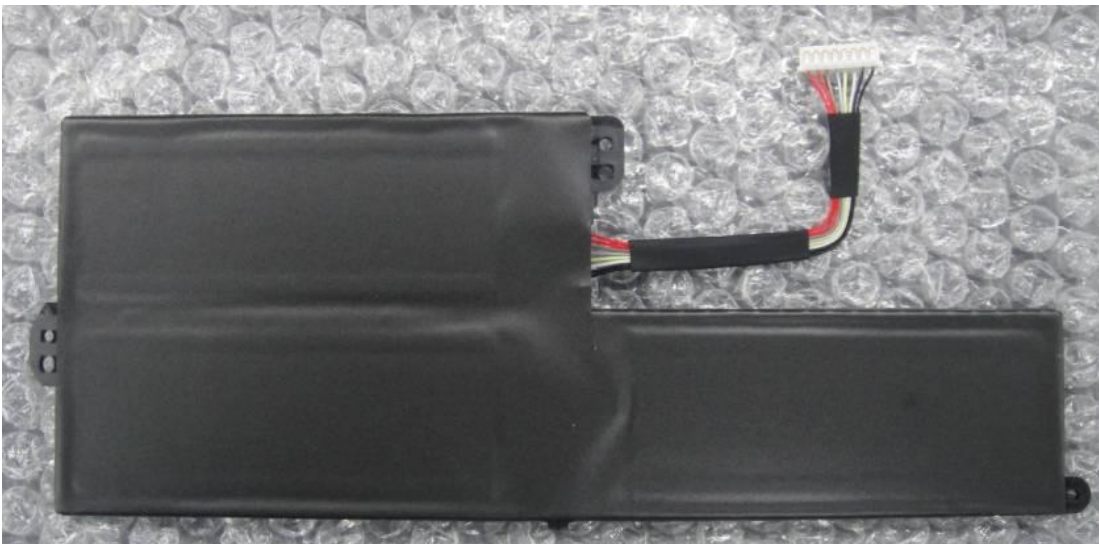


Figure photo of the pack.
