

Lenovo Global Environmental Management System Scope

Lenovo's Environmental Management System (EMS) reflects our commitment to design, develop and manufacture environmentally conscious products in facilities that minimize the environmental impact on their surroundings and to continually improve our performance in this area. Lenovo's product development organizations and manufacturing locations incorporate environmentally conscious product principles in the design and manufacturing process from concept and design to assembly to use and final disposal. Lenovo is committed to accomplishing this without negatively impacting product quality, function, or cost.

Lenovo is committed to the ongoing management of our compliance obligations and to meeting or exceeding applicable environmental requirements for Lenovo activities, products, and services, including legal requirements, standards and any voluntary commitments to which Lenovo subscribes.

Lenovo's EMS scope includes Lenovo's worldwide product design, development, and manufacturing operations (including distribution, fulfillment, and internal repair operations) for computer products and devices, data center products, mobile devices, smart devices, accessories, and converged network equipment. The scope encompasses these same activities when performed by our subsidiary and/or affiliate companies. In setting the boundaries and applicability of our EMS, Lenovo has considered our ability and authority to exercise control and influence on these operations.

Included in this scope are the following:

- Lenovo product design and development operations for product types listed above.
- Lenovo product manufacturing locations in Indaiatuba, Brazil; Chengdu, Hefei (LCFC), Huiyang, Shenzhen and Wuhan, China; Ullo, Hungary; Pondicherry, India; Gunma and Yonezawa (NEC), Japan; Monterrey, Mexico; and Whitsett, USA. Note: Manufacturing may include Lenovo products and non-Lenovo products.

The ISO 14001 EMS scope excludes activities that have been identified as having low environmental risk such as small offices, small product development locations, retail stores, field and service centers, sales, services and software development and any other activity not expressly listed above as being in scope. However, Lenovo's environmental policy and corporate instruction on environmental programs apply to these activities.

It is Lenovo's goal to leverage our EMS to help us address and mitigate some of the most significant environmental challenges facing us as a global organization. Our EMS focus areas include:
